Shelter Regulations

Shelter rental regulations are applicable to all groups and individuals and are as follows:

1. Please picnic in designated areas only.
2. Permit holders have priority over groups or individuals without a permit. If a group is using the shelter, show the party your permit and politely ask that they vacate the area. If a problem occurs, contact the Streamwood Park District office at (630) 372-PARK.
3. Parking and driving are permitted only on designated roadways and parking areas. Driving on park pathways is strictly prohibited.
4. Alcoholic beverages are prohibited in all Streamwood Park District parks.
5. Charcoal fires are permitted in Streamwood Park District grills only. Wood fires are prohibited in Streamwood Park District grills. Please extinguish your fire before you leave, and dispose of coals properly.
6. Litter should be collected and placed in litter barrels before you leave. The permit holder is responsible to see that the shelter area is left in a clean and orderly condition.
7. Electronically amplified sound is prohibited in Streamwood Park District parks. This does not include sound devices audible in the immediate area only.
8. Temporary structures (tents, stages, etc.) are permitted with prior written approval by the Streamwood Park District and appropriate Certificate of Insurance.
9. Fun equipment (inflatables, popcorn machines, dunk tanks, etc.) are permitted with prior written approval by the Streamwood Park District and appropriate Certificate of Insurance.
10. Parks close at dusk.
11. All rules and regulations of the Streamwood Park District must be observed, and the instructions of the Streamwood Park District staff members must be followed. Permit holders are responsible for planning and supervising the event in accordance with Streamwood Park District ordinances.
